ABOUT 15% WERE ZOO MEMBERS (NO RESERVATION WAS REQUIRED). SPECIAL EVENTS (BOO AT THE ZOO, SUMMER NIGHTS, SANTA) ACCOUNTED FOR 1900 VISITORS. WE CANCELLED OUR LARGEST FUND-RAISER OF THE YEAR (BREW AT THE ZOO). CONCESSIONS WERE LIMITED (WITH MASK REQUIREMENTS WE GREATLY REDUCED OUR FOOD OFFERINGS), THE GIFT SHOP LIMITED ONE FAMILY IN THE STORE AT A TIME.

WE WERE ABLE TO OFFER ZOO CAMP FOR 5 WEEKS (INSTEAD OF 10-11 USUALLY) WITH A GREATLY REDUCED NUMBER OF ZOO CAMPERS. WE RAN 17 FALL SCOUT WORKSHOPS. WE ALSO DID LOTS OF VIRTUAL PROGRAMMING ON OUR
