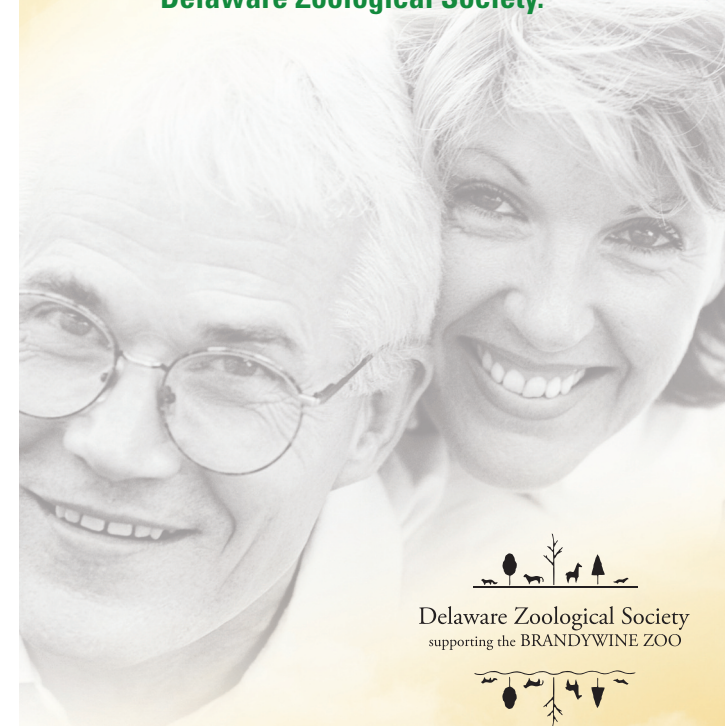

How to say it:

Sample Will or Trust Language

Retirement Accounts and IRAs

Consider adding the DZS as the first, second or final beneficiary of your IRA, 401(k) or other retirement account. This is one of the easiest and best ways to protect the animals you love.

This is a wonderful gift that can reduce taxes that may otherwise be due upon your death. You can name the DZS as a beneficiary or co-beneficiary by amending an existing policy or even purchasing a new policy. This is a great way to create a conservation legacy.

Certificates of Deposits, Savings accounts or other savings plans can pass immediately to DZS as a Payable on Death (POD) beneficiary of the account. Contact your financial institution to set this up today.
